







Lokalizácia VTP vo väzbe na mestá


Small city = <500,000 inhabitants

STPs and the number of universities within a 50km radius





How to read this graphic:

- 37% of STPs has between 1 and 5 universities within a 50Km. radius, etc.


Interakcia medzi VTP a univerzitami – zdieľaná infraštruktúra, zdieľane služby



Of the 4 parameters examined (sharing infrastructures, sharing services, hosting R&D groups, hosting ILO):

- 35% of STPs fulfils 2 of them, etc.



VTP a infraštruktúra v tis m²






Podiel parkov s výmerou 15-40000 m² a 40-80 000 tis m v EU

STPs with a built area between 15,001 - 40,000 m² (Europe)






STP with a built area between 40,001 - 80,000 m² (Europe)





Rozpočet VTP


STPs Annual operating budget (Europe)


Vlastnícka štruktúra VTP

STPs Ownership Structure (Worldwide)






Vlastnícka štruktúra VTP-súkr.sektor




Zmiešaná vlastnícka štruktúra VTP






Manažerská štruktúra VTP






Formy a % podiel verejnej podpory VTP




Fázy verejnej podpory VTP





Support Granted to fully operational parks (Europe)







Počet firiem etablovaných vo VTP




50% of STPs world wide have, as per today, 100 resident companies or less. At the other end, 20% have more than 200 companies. Middle-size STPs (those with 101 to 200 companies) represent 16% of the Parks world wide.

Podiel firiem v parkoch v EU




Obsadenost' VTP



- 50% of STPs are quite 'full', with an occupancy rate between 81% and 100% of their total capacity.


Odkial' pochádzajú firmy

- The STPs with the largest proportion of regional tenants are located in Central and in Southern Europe (34% and 33% respectively).
- Southern European Parks are, by far, the ones that have more foreign tenants.
- Northern Europe is the region that holds the highest number of STPs with national tenants.





Podiel firiem v VTP nad 250 zamestnancov




- 72% of STPs have less than 10% of tenants with more than 250 employees
- In 8% of STPs, tenants with more than 250 employees represent 10% to 20% of all the Park tenants, etc.

Podiel MNC vo VTP




- In 37.7% of STPs, the number of multinational tenants represents less than 10% of all tenants.
- In 20.8% of STPs, the number of multinational tenants represents 10% to 20% of all tenants, etc.

Technologicky orientované firmy




- In 39% of STPs, the tenants selling their own technology products/services represent 76% to 100% of all companies located in the Park, etc.

Tvorba nových pracovných miest v VTP




In Europe 23% of STPs have a population between 800 and 1,500 people, and 12% already have over 3,000 people.
